5-10 miles over- \$125.50 fine, court costs \$24.50: \$150 total fines and costs

11-15 miles over \$150.50 fine, court costs \$24.50: \$175 total fines and costs

16-20 miles over \$175.50 fine, court costs \$24.50: \$200 total fines and costs

SPEEDING IN A CONSTRUCTION ZONE WITH WORKERS PRESENT

5-10 miles over \$225.50 fine, courts costs \$24.50: \$250 total

11-15 miles over \$250.50 fine, court costs \$24.50: \$275 total

16-20 miles over \$275.50 fine, court costs \$24.50: \$300 total
